A VERY GOOD YEAR

Dear Friends,

It was a very good year for Wayne County Community Foundation. We recorded \$6.9 million in gifts, and returned more than \$3.6 million to the community in grants for an array of charitable programs, scholarships, and capital needs. Total assets grew from \$56 million to \$64.5 million.

We are pleased that the Foundation continues to grow, because that vitality is crucial to our mission: "To provide philanthropic leadership to our community". In this regard, unrestricted "community funds" are especially important, as well as funds that are permanently endowed. These assets



allow us to respond to community needs through our twice-yearly competitive grants program, and also to drive major philanthropic initiatives within Wayne County.

Each year, in this Annual Report, we summarize our year's activities, report on our investment performance, and share stories of Wayne County residents who have chosen to share what they have with others. You'll probably see some familiar faces within these pages. WCCF offers a variety of programs that enable individuals, charitable agencies and businesses to achieve their philanthropic goals, and to create a lasting legacy for the causes they care about.

The GIVE 365 program, launched in the past year, provides funds to spend, builds a permanent endowment, and engages individuals of all ages in active grant making. Membership costs only \$365–just a dollar per day. The first year fulfilled its promise and we are already making plans for Year Two. Read all about it on pages 8 and 9.

In December, WCCF received a wonderfully generous grant from the Burton D. Morgan Foundation of Hudson, Ohio. The grant was made in honor of the late Stan Gault, who served as a Trustee of the Morgan Foundation for more than 20 years. The gift was made with the expectation that WCCF would match the Morgan grant to bring the Fund to one million dollars or more. The Stanley C. Gault Philanthropic Leadership Fund is a permanent endowment which support programs that enhance the quality of life for Wayne County citizens, and that sustain the economic vitality of this region. Wayne County is fortunate to have many individuals and families whose generosity has significantly enhanced the quality of life in our community. This year's Friend of Philanthropy recipient, Barry Romich, exemplifies multi-faceted and creative philanthropy. You can read the story on pages 10 and 11.

GIVE~365 philanthropy on a Dollar a Day

Wayne County

GIVE 365, a new program launched this year, unites and informs emerging philanthropists to make a collective impact on Wayne County, Ohio. With only a \$1 a day – or \$365 a year – pooled with other donors, members can join together to make a greater impact with their philanthropic dollars, as well as to learn about the nonprofit organizations that are making our communities better places to live and work. It also gives those organizations a way to demonstrate, to a captive audience, their impact and their potential.

Why GIVE 365?

GIVE 365 allows you to leverage your charitable contributions with others to support nonprofits throughout Wayne County. The larger the membership of the fund, the greater the impact.

Through GIVE 365, you will engage in philanthropy with your peers. You will share what you know, and you will learn about the issues facing Wayne County and the agencies that work to make our community a better place.

Who is eligible to join?

Anyone! Even those who are not interested in active membership, but want to support the program, can do so by sponsoring someone to participate (i.e. children, grandchildren, employees), providing matching grants to GIVE 365 awards, or by making a donation of any amount.

Once I join, what are my obligations?

One of the hallmarks of the program is that GIVE 365 membership is inclusive and flexible. Members can participate in a way that fits their schedules and lifestyles. Some members simply contribute financially. Others serve on the grant review teams that research nonprofits and narrow the field of grant applicants to finalists. But every member, no matter their level of involvement, gets the opportunity to vote on grant recipients. Your only obligation, once you join, is to educate others about this opportunity.

Membership Contribution

The annual contribution is \$365 – a dollar a day – payable by June 30th each year. We offer one-time or quarterly payment options. All gifts are tax deductible.

Where does my gift go?

Annual membership gifts, matches and general donations up to \$3,649 are allocated 50/50 between the GIVE 365 annual grant fund and the GIVE 365 endowment fund. Lifetime membership gifts of \$3,650 or more are allocated at 5% to the GIVE 365 annual grant fund in the year received, and 95% to the GIVE 365 endowment fund.

The GIVE 365 endowment fund is a permanent charitable account where the principal is retained and reinvested. Every year, the earnings are used to provide charitable grants, in accordance with the Wayne County Community Foundation's spending policy. Over time, the fund's balance will grow, as will annual income available for grant making.

Sounds great, but I already support charities I care about.

And we hope you will continue to do so. GIVE 365 is in no way a substitute for directly supporting the causes and organizations important to you. GIVE 365 is an initiative to grow the impact of your charitable giving, to become involved in philanthropy in a way that might not be available to you individually. By learning together about the needs of Wayne County, members will be able to foster innovative solutions to local problems.

GIVE 365 GRANTEES

The focus for 2017 grant making was on Drug Prevention in Wayne County.

This year, the membership made awards to two local nonprofits: OneEighty, Inc. and Wayne County Schools Career Center.

OneEighty, Inc. was awarded \$7,000 for a countywide Prescription Drug Education Campaign. Using a variety of media, the organization will inform residents of Wayne County – young and old – about the harms of abusing, misusing, buying, selling and ingesting prescription drugs.

The Drug Free Clubs of America at Wayne County Schools Career Center received \$3,000 to be used to further expand their existing program. The program at WCSCC began two years ago and currently has nearly 500 members. The program has shown great success in preventing drug use, with 99% being found drug free in random drug testing. The program reinforces good choices and promotes positive peer pressure.

His father was a farmer, a village councilman, and a volunteer fireman. His mother, an elementary school teacher with a passion for music. They both served their church and volunteered throughout their local community.

Through it all, their young son Barry watched. And he learned. The lesson? It is important to give back. Generosity is a virtue. Take care of those in need.

And so, as Barry Romich built a successful career, he kept that lesson in mind. Because of his success as a business owner, Romich was able to start the Romich Foundation and establish the Romich Family Fund at Wayne County Community Foundation.

A native of Creston, Ohio, Romich studied engineering at Case Western Reserve University. As a student working part-time in a research lab, he met Ed Prentke, an engineer at Highland View Hospital in Cleveland, Ohio. The two men, very different in age, background, and personality, soon found they had a mission in common: to help individuals with disabilities. Prentke and Romich decided to form a partnership and, in 1966, the Prentke Romich Company (PRC) was born. Over the years, the company has grown and today employs over 200 people through several international subsidiaries. In 2003, the company began to transition to an employee stock ownership plan. After stepping down as president of PRC, Barry turned his focus towards projects closer to home, lending his expertise unselfishly.

Through the Romich Foundation and his fund at WCCF, Barry supports schools and nonprofit organizations that promote STEM education (science, technology, engineering and mathematics) in Wayne County, Ohio. Several years ago, Romich had the opportunity to attend a few state and national competitions for students interested in robotics, technology, and engineering. This experience prompted him to wonder, "Why isn't this happening in Wayne County?" So, he made it happen! Working with area school districts, Romich was instrumental in furthering STEM education and bringing robotics clubs to students across the county. Northwestern Local Schools now has programs for students in kindergarten through 12th grade.

Dalton Intermediate School's STEM program partners with local businesses to focus on projects to create sustainable living. "The Nerd Herd", a robotics club at Chippewa Middle School, has also benefited from Romich's generosity. And Romich's home school district, Norwayne Local Schools, now has a number of STEM and maker initiatives. In addition, University of Akron – Wayne College has been able to expand their 3D printing initiative, including CAD design and developing a maker space.

Another particular interest of Romich's is to serve the needs of disadvantaged

individuals. Thanks to his generosity, the Wayne County Park District was able to construct an ADA-accessible pavilion at the Barnes Preserve in Wooster. In addition, the Cornerstone PlayLab received support to create an ADA compliant, safe play space for all youth, including those with disabilities.

Romich is also a proponent of sustainable energy. One of the first projects he supported through his foundation, in conjunction with the Wayne County Sustainable Energy Network (where Romich is a board member), was the creation of a solar power station for Habitat for Humanity. The towable trailer allows Habitat to use renewable energy to power a variety of tools at construction sites. Romich was also instrumental in bringing sustainable energy to Norwayne Elementary, utilizing solar panels on a pavilion in the outdoor classroom space. Solar panels have also been installed on the concession stand at Norwayne High School athletic fields.

When asked if there were anything he'd do differently, Romich responded that he would have liked to have started being more "intentional" with his giving from the very beginning. "Earlier in my career, it was never my plan for Romich Foundation to exist," states Romich. "The modest wealth that was achieved was sort of an accident, a natural by-product of a successful business." Through Romich Foundation and WCCF, Romich and his wife, Robin Wisner, have discovered the joy of philanthropy and it is now part of their daily lives.

In establishing the Friend of Philanthropy Award, the Foundation wanted to recognize the difference that individuals can make through personal commitment and leadership, taking into account the impact such individuals have on our community, and the role that their creativity and advocacy can play in a project's success. Barry Romich embodies the very best of all these qualities, and has generously shared them with the members of this community. Romich truly appreciates the Wayne County community, stating "What we have is excellent. It doesn't stay that way without involvement from the community. We all have an obligation to give back what we can."

GAULT LEGACY CONTINUES

THEIR EXTRAORDINARY GENEROSITY

and ability to engage and inspire others were unprecedented. Philanthropists like the Gaults are rare indeed – and Stan's passing in 2016 marked the end of an era.

To perpetuate his legacy and memory, the Stanley C. Gault Philanthropic Leadership Fund was established at WCCF in December 2016 with a grant from the Burton D. Morgan Foundation of Hudson, Ohio, in recognition of Mr. Gault's more than 20 years of service as a Morgan Foundation Trustee. When he retired from the Board in 2015, Morgan Foundation President and CEO Deborah Hoover stated: "Stan guided the evolution of the Foundation through steadfast contribution of his wisdom, time, and many talents, freely sharing his vast experiences and generously mentoring others."

In making the \$500,000 award to WCCF, Ms. Hoover said: "The Morgan Foundation Board believes that this gift will perpetuate Stan Gault's exemplary leadership, and will demonstrate our great admiration and appreciation for his pivotal contributions to the Foundation."

The Gault Fund, a permanent endowment, will make grants to non-profit entities whose work supports the well-being of citizens in Wayne County, Ohio, through projects that enhance the

An advisory committee will govern the Gault Fund and advise on the development of community projects that focus on Gault's philanthropic philosophy. The goal for the Fund is to perpetuate the ideal of service and active involvement in philanthropy that Stan embodied throughout his life.

Trustees of the Morgan Foundation expressed the hope and the expectation that WCCF would seek additional support from those who worked with Stan, and who wish to honor him and the difference he made in our community. The initial goal was to match the Morgan Foundation's grant – creating a permanent endowment of at least \$1 million. Thanks to the generosity of individuals, corporations, and foundations who knew Stan well and worked closely with him, the Gault Fund has exceeded that initial goal and has begun to work on the second million.

JONES SCHOLARSHIP CONTINUES LIFELONG GENEROSITY





"Never be afraid to help anyone." That guiding principle shaped Ralph and Grace Jones' standard of excellent customer service at Wooster Glass Company.

It also had a wider reach, as the couple volunteered for community projects, provided support for a wide array of charitable organizations, and, of course, in relationships with their family, friends, and church. Grace died in 1997 and Ralph passed away in 2010. Both left a legacy of memories, packed full of respect, charity, and laughter.

One of their passions was supporting youth and education. Before his passing in 2010, Ralph wisely established the Ralph R. and Grace B. Jones Foundation to support the ongoing charitable needs of the community. Now overseen by family members, the Jones Foundation established a scholarship to help Wayne County students continue their education, with preference given to students who are the first in their families to attend college.

Receiving the Ralph R. and Grace B. Jones Community Scholarship in its inaugural year was Tyler Morr, a graduating senior of Northwestern High School. Tyler will be pursuing a degree in Mechanical Engineering at Ohio Northern University.

A leader on and off the field, Tyler was a fouryear varsity letter winner in soccer, a member of the National Honor Society, and a Boy Scout, achieving the rank of Eagle Scout. Through his volunteer and community service activities, Tyler exemplifies the values Ralph and Grace held dear.

In his application essay, Tyler stated **"Being** an active member of my community is something that is vital to me...it gives a person perspective and is an important



aspect of character development. Service opens your eyes and gives you a better sense of the real world." Ralph and Grace would surely agree with those sentiments.

GROWING FOR THE FUTURE

Major changes are underway at Orrville Area Boys and Girls Club (OABGC) as the organization plans for its future growth.

This year, OABGC launched a \$1.5 million capital campaign to add 10,000 square feet to its facility – creating additional educational spaces, a multi-purpose room, and handicapaccessible restrooms. In addition, the plan includes renovations that will double the size of the Kids Café and Kitchen. This expansion will enable OABGC to serve more youth in the Orrville, Dalton, and Smithville school districts.

In the five-year period from 2011 to 2016, the organization saw a 383 percent growth in the number of youth served. Currently, more than 500 youth, on average, are served each day through a variety of academic, enrichment,

and athletic programs. The expansion will nearly double the capacity of the space so that more working parents can be sure their children are in a safe, secure, and supervised location. In addition, OABGC currently provides over 54,000 meals each year. The kitchen expansion will allow 20 percent more children to be fed.

To assist with the expansion, Wayne County Community Foundation awarded OABGC a \$17,000 grant through the Carl E. Congdon, Jr. and Susanna Congdon McIntyre Memorial Fund, which is restricted to supporting nonprofit organizations serving the Orrville community.

Construction began in April 2017, and is scheduled to be finished in Spring 2018.





TEAMWORK BRINGS UPDATES TO AMERICA'S GREATEST PASTIME

For nearly 70 years, Wooster Youth Baseball, Inc. has provided boys and girls in the community the opportunity to participate in the great American pastime.

Founded in 1948, the league operates as the only official Little League of America affiliated baseball program in Wayne County. With donated land on the corner of Portage Road and Highland Avenue, the original baseball fields were constructed in 1958. The facility received a facelift in 1994. With no substantial improvements to the Miller Fields Complex since then, the organization decided it was time to launch a campaign to fund some



much needed capital improvements. The organization established the Wooster Youth Baseball Fund at the Foundation to facilitate the campaign.

Each year, Wooster Youth Baseball serves some 300 children ranging in age from 4 to 12 years old, and their families, from Wooster and throughout Wayne County. Through their programs, youth are encouraged to practice sportsmanship, honesty, courage, and respect. Wooster Youth Baseball is one of our community's great assets. But the challenge grows to continue a program that is open, affordable, and accessible to every child in the community, while maintaining facilities that are decades old. The \$1.5 million capital project will provide for a complete renovation of the Miller Field Complex – including field and fencing upgrades, new dugouts and lighting, a concession stand with meeting facilities, and ADA compliant restroom facilities.

Through the Foundation's competitive grant cycle, Wooster Youth Baseball was granted a total of \$25,000 from the Florence L. Rice Community Fund, Lillian Steiner Community Fund, and an Anonymous Community Fund, earmarked for the capital campaign.

SCHOLARSHIPS HELP STUDENT ACHIEVE LIFE-LONG DREAM

... the Foundation has a strong and vital scholarship program for non-traditional students.



When most people hear the word "scholarship", they envision high school seniors preparing to head off to college. However, the Foundation has a strong and vital scholarship program for the nontraditional student as well. Orrville resident, Carrie Gress, is taking full advantage of these opportunities.

A 1990 graduate of Wooster High School and Wayne County Schools Career Center, Carrie dreamed of someday becoming a nurse. But as a single mother of two children, working full-time, that dream was placed on hold. Her third-shift position as a State Tested Nurse Aide proved difficult for raising two small children. So, she returned to school to obtain the computer skills necessary to move into a secretarial position within a medical office. Carrie's hard work and perseverance paid off for her and her children, as they were able to move into their very first home, built by Habitat for Humanity. Prior to breaking ground on their own home, Carrie had put in over two hundred hours of volunteering with Habitat, helping build houses, landscaping, and preparing meals for other volunteers.

For the past fifteen years, Carrie has held a number of secretarial roles for The Cleveland Clinic. Working in a variety of specialty departments provided Carrie with new skills and a wealth of knowledge in the medical field. Her dream of becoming a nurse never wavered. With her children now grown, she is determined to pursue the career she always dreamed of having. Carrie has enrolled in the full-time Licensed Practical Nursing program at Wayne County Schools Career Center.

To help pay for the program, Carrie applied for a number of scholarships at the Foundation. Several of our independent selection committees found her story, and her recommendation letters, to be compelling. Carrie was awarded a combined total of over \$10,000 in scholarships from the Carlos Appleman Scholarship, Flo K. Gault Scholarship, Zody Miller Scholarship, and Empowering Women Through Technical Education Fund.

With her children now grown, she is determined to pursue the career she always dreamed of having.



RENOVATION BRINGS BUILDING BACK TO LIFE

The Fredericksburg Community Library opened its doors in 1998, creating a gathering space for both the English and Amish members of the community. It became a safe space for children to learn, a place for neighbors to come together, and a repository where historical information could be stored and displayed for all to enjoy. Staffed entirely by volunteers and supported by local businesses and individuals, the library has truly become a "place to find good books and good friends".

A grant from the John G. Taggert Community Fund will help the library to restore The McCay House/ Weaver Grocery Store Building. Designated as a "Pioneer Home" by the Wayne County Historical Society, The McCay House, situated at the main intersection of town, will be revived after years of neglect. Originally built in the 1850's, the house will soon come back to life. The renovation and preservation efforts will provide ample space for historical displays, a retail coffee shop, a place for local artists to display their work, and additional space for Simply Hand Made, a non-profit gift shop which provides ongoing revenue for the Fredericksburg Community Library.

The McCay House renovation project will not only provide a place for local history to be explored and displayed, but also will be a beautiful enhancement in the town of Fredericksburg.





4-H EMPOWERS YOUTH

Since its founding more than 100 years ago, 4-H has become the nation's largest youth development

organization. The 4-H idea is simple: help young people and their families gain the skills needed to be proactive forces in their communities and develop ideas for a more innovative economy.

Locally, 4-H serves over 1,500 individuals, ages 5 to 19, through a variety of programs – helping them "learn by doing" through hands-on activities. Among all the fun things to learn about in 4-H are animals, computers, public speaking, cooking, art, gardening, natural sciences, and much more.

In addition to youth development, Wayne County 4-H offers a number of scholarships to local students who wish to pursue a post-secondary education. Two of these scholarships are now awarded through Wayne County Community Foundation. Wayne County 4-H General Scholarship Fund offers awards to current or former 4-H members, while the Wayne County 4H/FFA Doyle Findley Scholarhship Fund makes awards to present or former members of the Wayne County, Ohio, 4-H or to FFA members who have completed a livestock project.

4-H empowers young people to reach their full potential. The scholarship program is 4-H's sound investment in the future.

Competitive Grant Application Guidelines

The Foundation makes grants only to organizations that are recognized by the Internal Revenue Code as nonprofit, tax-exempt, charitable organizations including schools and churches; or to qualified governmental agencies. The Foundation does not make grants to individuals. All scholarship checks go to the schools where the student is enrolled.

Unrestricted donations to the Foundation are added to the General Fund. Along with other Community Funds, these gifts allow the Board of Trustees to respond to innovative projects and the changing needs of the community. Charitable organizations serving the residents of Wayne County, Ohio are invited to apply for grants through our competitive grants process. Application deadlines are March 1 and September 1 each year. GIVE 365 announces their focus area in January, with a grant application deadline of March 1. The Women's Fund accepts grants applications once a year, with a deadline on September 1. Nonprofit organizations serving Wayne County youth may also apply to the Youth Foundation by February 1 each year. 

how investments grow charitable funds. They met with local philanthropists and also evaluated grant requests from organizations serving Wayne County youth.



Assets Since Inception



Asset Growth

As of June 30, 2017 the Foundation's assets exceeded \$60,000,000 for the first time. This increase in the Foundation's assets over the years since 1978 is detailed in the graph above.

Assets have increased from slightly over \$10,000,000 in 1997 to over \$62,000,000. This growth in the Foundation's asset base is driven by gifts to the Foundation detailed in the previous pages of this Annual Report and by investment returns on the Foundation's portfolio of assets which are dealt with in the next paragraphs of this section.

Investment Management

The Foundation's investible assets are almost exclusively financial assets comprising an investment portfolio of just over \$62,000,000 (as detailed in the Financial Statements portion of this Annual Report). This investment portfolio is managed by the Investment Committee of the Board of Trustees with guidance from the financial professionals at Hartland & Co. of Cleveland, Ohio. The Foundation invests its portfolio to provide a stable, continuous stream of grants to support the nonprofit needs of the Wayne County community.

In its fiscal year ended June 30, 2017, the Foundation's investment portfolio earned a total return of 11.5% net of all fees and other costs. The Foundation does not seek to obtain double digit investment returns, but after a couple years of muted returns, this year's investment results were most welcome. This was our first year with Hartland & Co. While we do not expect this level of returns every year, we do appreciate them when they are realized.



A diverse portfolio is fundamental to WCCF's investment strategy, which aims to maximize investment returns while reducing volatility. The Investment Committee of the Board of Trustees regularly reviews the asset allocation strategy.

The Foundation's Investment Committee is comprised of individuals with financial experience who establish policy, hire investment managers, and evaluate performance. In turn, the Investment Committee is advised by independent investment consultants, Hartland & Co. of Cleveland, Ohio. WCCF's custodial bank is Huntington National Bank, Inc. (formerly FirstMerit Bank).
