### Community Foundation receives \$100,000 Challenge Grant Women's Fund Created

The Wayne County Community Foundation has received a \$100,000 challenge grant from The J.M. Smucker Company to establish The Women's Fund. The newly created Women's Fund will positively impact the lives of women and children in Wayne County by directing resources to organizations that support the education of women and empower change and self-sufficiency.

Despite dramatic advancements by women in recent decades, women are still far more likely than men to be homeless, live in poverty, be unemployed or under-employed, face violence, or suffer from inadequate housing and healthcare. More women than men are single parents, responsible for the care and protection of their children.

Aware that just seven percent of all philanthropic dollars raised in the nation are earmarked for programs for women and girls, the Fund was created to focus on projects and programs that create opportunities for **educational advancement**, **economic empowerment**, and enhancement of the **quality of life** for women and children throughout the County. With the commitment from The J.M. Smucker Company of \$100,000, the Foundation will need to raise an additional \$200,000 before June 30, 2016 to meet the challenge. Once the challenge is met, the permanently endowed fund will provide more than \$10,000 each year to support women in Wayne County, and grants will continue to increase as the endowment continues to grow. As a permanent endowment, The Women's Fund will be able to meet community needs far into the future.

Overseen by an Advisory Committee, the Women's Fund will be operated by women, for women. Members of the committee will invite and review grant proposals, work with service agencies, and recommend grants to the Community Foundation each year.

## The Power of Endowment

### Providing for community needs, now and in the future

You've lived here. You've worked here. You are part of this community's past and present. By creating an endowed fund with the Foundation, you can invest in this community's future.

At the heart of the mission of the Foundation is building a permanent endowment to ensure that the charitable needs of Wayne County can be met in future years. Permanent Endowments are funds in which the principal is preserved and invested, with a portion of the earnings distributed annually for charitable purposes. Over time, distributions exceed the original gift, while the fund balance continues to grow, thanks to responsible management. By creating a permanently endowed fund at the Foundation, you will be providing for community needs in perpetuity.

#### Your charitable plan made permanent

An endowment is a permanent fund, with a number of advantages. An endowment will:

- Provide dependable, perpetual income to your chosen cause or nonprofit be it the arts, your house of worship, your alma mater or whatever cause you love
- · Carry on your family's name and legacy forever
- · Allow successive generations to continue family giving traditions

Endowments offer magnificent benefits to your favorite nonprofits: Depending on their size, an endowment could mean the difference between vitality and bankruptcy, or creativity and complacency.

The following chart illustrating the "Power of Endowment" is based on an endowed fund established with \$10,000. It shows how you can "Give It Away and Still Keep It".



Assumes an 8% ROI, 1% administrative fee and 4.5% grant payout each year. This example is not a guarantee of return on investment.

The award is made on the basis of an organization's commitment to the quality of life, social conscience and betterment of the community, and it includes a \$1,000 contribution from the WCCF to support the continuing efforts of the organization.
