Friend of Philanthropy Award Created Nominations being accepted

The Wayne County Community Foundation (WCCF) is pleased to announce the "Friend of Philanthropy Award" to be awarded for the first time in 2013. This award will honor those who make a difference in our communities with their philanthropic activities, which can include financial contributions that benefit the community; volunteering; and giving of their time, resources and skills for the betterment of the Wayne County area.

Eligible nominees will be individuals or couples who demonstrate a continuing history of volunteer work and/or contributions that advance the quality of life or grow community philanthropy in Wayne County, Ohio. The recipient of the award will be honored at the WCCF Annual Dinner, to

be held on Wednesday, October 9, 2013 at the Arden Shisler Conference Center. Winners will also be recognized on a permanent display at the WCCF offices. In addition, a \$1,000 grant will be made on their behalf to the charity of the recipient's choice.

Anyone residing or working within Wayne County may recommend deserving nominees. Nominations must be received at the WCCF office by Noon on August 15, 2013. Full guidelines and nomination forms are available on the Foundation's website or by calling the WCCF office at (330)262-3877.

Nonprofit Spotlight People to People Ministries

For most people, the arrival of summer means slowing down a little, taking vacations, enjoying picnics and barbecues – but for Lydia Stahl, things are just starting to heat up! As the executive director of People to People Ministries, Lydia is busy gathering her staff and volunteers to coordinate two of the organization's biggest annual projects – the Back to School and Holiday Toy Projects.

Held each August, the Back to School Project helps get school supplies, clothing and shoes into the hands of hundreds of eligible Wayne County children. Most of the items kids will receive are donations from the community. While the project is coming along smoothly, there is still a need for donations of, or monetary donations for, backpacks. Last year, over 300 volunteers for the Back to School Project helped prepare over 800 kids for school.

The Holiday Toy Project, held each December, takes

months of planning and gathering of gifts. Through this program, People to People is able to provide a range of toys and holiday gifts for some 1,200 children annually in the Wayne County area. They are currently accepting donations of gifts and toys for babies and children to age 18. However, this year's biggest need is for a secure storage location of approximately 2,500 square feet to house the inventory before the holidays.

Income-Producing Gifts

Making a gift that generates income for yourself or for loved ones

If you wish to make a significant gift to the community but are not sure you can comfortably give up the assets, you may want to consider one of our income-producing gift options. These gifts can provide an income stream for yourself and/or your spouse, children, and others. Life-income gifts allow you to take advantage of government tax laws that are designed to encourage philanthropy – offering current income tax deductions. They may also provide an opportunity to avoid or reduce capital gains tax on assets that have substantially appreciated. Plans can also be used to minimize estate taxes. The most popular life-income gift options are charitable gift annuities and charitable trusts.



Charitable Gift Annuities: A charitable gift annuity provides a way to make a meaningful gift while enjoying guaranteed income and tax benefits, thus also enhancing your financial well being. Under the terms of a gift annuity, you make a charitable gift of cash or other property and then receive guaranteed fixed payments for your lifetime. You are entitled to an income tax deduction in the year of your gift and, for a period of time, a portion of each payment may be free of income tax or taxed at capital gain tax rates that are lower than tax rates on other income.

Charitable Remainder Unitrusts: When you prefer an income that varies with market conditions, consider a charitable remainder unitrust. A unitrust allows you to make a major gift, typically of real estate or securities, while continuing to receive income from your gift during your lifetime. Payments are based on a specific percentage of the value of the trust as it is valued each year and thus may vary from year to year. In addition to the income you will receive from the trust, you will also be entitled to a charitable income-tax deduction for the value of the remainder interest in the trust asset. When the last beneficiary dies, the unitrust assets will benefit any WCCF fund you choose.

The type of asset being given, and the age and specific needs of your beneficiaries all help determine which vehicle is right for you. Our staff can work closely with you and your financial advisor to determine the best way for you to make a planned gift.

The Wayne County Community Foundation does not provide tax advice and encourages donors to consult their accountant, financial advisor, or tax counsel, regarding all tax matters related to charitable gifts to the Foundation.

Over \$400,000 in scholarships awarded

Foundation's Board Awards Grants

Spring Competitive Grant Cycle invests more than \$48,000 in the community.

The Wayne County Community Foundation (WCCF) Board of Trustees approved \$48,100 in competitive grants when they met in May. Competitive grant applications from nonprofit, tax-exempt, charitable organizations are accepted March 1st and September 1st each year. Community funds and field of interest funds permit the board to be responsive to the changing needs of the community. The following organizations received discretionary grants:

Akron-Canton Regional Foodbank received \$5,000 for the purchase of a new day cab tractor. This purchase will eliminate their current need to lease a tractor, saving the organization an estimated \$255,000, over the next 10-years, and thereby enable the Foodbank to allocate more of their funds to food distribution. Last year, the foodbank provided 186,000 pounds of food to over 7,600 people throughout Wayne County.

Central American Medical Outreach Inc. (CAMO) was awarded \$5,000 to help purchase land surrounding their physical office space in Orrville. This space will eliminate their current land lock and will enable them to meet future facility expansion needs, including parking spaces, additional storage space for medical supplies and equipment, a shipment preparation area for volunteers, and a clean room separate from existing work space that will limit equipment exposure to dirt and dust.

Rails-To-Trails of Wayne County received \$10,000 for the construction of a 2.4 mile rail-trail from north of Orrville to Marshallville. The asphalt trail is a segment of the Ohio-to-Erie Trail, a 240-mile green corridor from the Ohio River to Lake Erie. When completed, the Wayne County section of the Trail will connect the Holmes County Trail, in Fredericksburg, to the Towpath Trail, in Clinton.

Rittman Police Department/City of Rittman will use their \$8,600 grant to construct a building for safe, secure storage of their firearms training and range equipment. In addition, this building will provide more room to host classes.

Rittman Recreation Center/City of Rittman received \$10,000 to purchase dumbbells, kettlebells, medicine balls, pro-fitness bars, and workout mats, as part of their Facility Improvement Program/Equipment Procurement Program.

Sterling United Methodist Church was awarded a \$2,000 challenge grant. Pending the acquisition of challenge dollars, this grant will be used to purchase a 50 cubic foot commercial refrigeration unit for their Bountiful Box Program.

Wayne County Historical Society of Ohio received \$3,500 to replace the frame surrounding the five large display windows in their General Store and Clothing Shop, which was moved piece by piece onto the Society campus from Fredericksburg in 1997.



West View Manor Inc. was awarded a \$4,000 grant to procure an interactive and adaptive computer system that will provide a person-centered experience and enhance the quality of life of their residents. By utilizing *Its Never 2 Late* (iN2L) adaptive computers, their residents will have access to activities that encourage lifelong learning and exploration, programs for cognitive stimulation, physical engagement and fun, email and web cam capabilities and connection to large screen TVs and projectors for group engagement. Their therapy department will also be able to utilize this computer system in providing Physical, Occupational and Speech Therapy modalities to their Residents.

The WCCF Board of Trustees also serves as the advisors for the **Laura B. Frick Charitable Trust**, which awarded \$66,700 in grants to local Wayne County organizations during their May meeting.

Grant guidelines and application forms are available at the Foundation or on our website. Additional donations to Community Funds by individuals, families, businesses and service organizations allow for greater future grant opportunities.

Allen to speak at Foundation's Annual Dinner



WCCF will hold its annual dinner on Wednesday, October 9th. Dr. Allen was named the third president in the organization's history in December 2012. Prior to accepting the position, she was Vice President of Development and Donor Services for the Akron Community Foundation. In addition, Dr. Allen has held leadership, teaching and senior development positions with several institutions of higher learning, including the University of Akron, Walsh University and Kent State University. During her career, Dr. Allen has also acted as a private consultant, serving clients in the nonprofit and academic sectors.

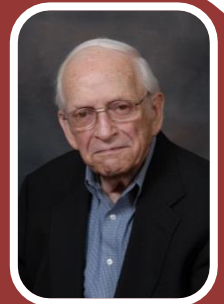

Seiwert a great asset and greatly missed

Robert C. Seiwert, 1921-2013

The Wayne County Community Foundation (WCCF) lost one of its greatest assets this spring as Robert (Bob) Seiwert, one of the original founders of the organization, passed away on May 3rd. Bob was instrumental in ensuring the success of the WCCF.



While he already had a full-time job, Seiwert took on the role of being the first executive director, a role he held for 16 years. He not only managed the Foundation entirely out of his office, but also paid all of the operating expenses himself. In 1996 Bob was elected to the WCCF Board of Trustees and remained a member until his passing.

It was Bob's insight to have the first office of the WCCF in Smithville, an effort to ensure that the Foundation was truly a Wayne County resource and not one focused on Wooster or Orrville alone. This strategy turned out to be quite successful, as the Foundation is approaching its 35th anniversary and celebrating some impressive milestones: since inception the Foundation has awarded over \$53 million in grants and scholarships while its asset base has topped the \$50 million mark.

Seiwert's faith was his foundation. He always looked beyond himself and wanted others in the community to be able to enjoy the fruits of his efforts and benefit from the work of the Wayne County Community Foundation. Without the leadership, vision, and energy of Seiwert and the other core founders, the Foundation would not be the thriving organization it is today.
