Funding Spotlight James A. Boyd Fund



Established in 2011, the James A. Boyd Fund is a permanent endowment to be used for youth athletic activities, health and fitness programs, and support for non-profit agencies in financial need.

A sudden heart-attack took Jim Boyd's life just a few weeks before his 60th birthday, but his memory lives on through his selfless acts of kindness and compassion. Some may remember Jim on his family farm near Berlin or during his Hiland High School days or his classes at Malone College. Others may recall his days working at Wooster Community Hospital and The College of Wooster. Still others will remember his passion for baseball and marathons.

But most will remember him as the longest serving staff member of the Wooster YMCA. While that 35year tenure is impressive, it is Jim's quality interaction and genuine care for others at the YMCA fitness center that people recall most vividly.

Jim's legacy will not be forgotten because community leaders helped establish the James A. Boyd Fund.
