Annual investments have strong performance

At Wayne County Community Foundation, we believe that strong, consistent investment returns are best produced by maintaining a disciplined investment philosophy and process over time. We accomplish this by adhering to several core principles that emphasize asset allocation, portfolio diversification, manager selection and a long-term view.

Maintaining a disciplined investment strategy and adhering to our core principles have been fundamental to generating strong performance. We are pleased to report that our investment pools have generated solid results, with an investment gain of 13.97% for the fiscal year ending June 30, 2014. This return rate is net of all investment and banking fees, except the WCCF's administrative fee of approximately 0.6%.

The Community Foundation's record of excellent financial management and strong investment returns is an important element of how we serve donors and nonprofits and grow the community's charitable capital.

Matthew named president of the Board



The Wayne County Community Foundation has announced Steve Matthew's election as President of the Board of Trustees. Matthew has served as a Trustee since 2009, representing Wooster. In addition to his role as President, he will serve as an ex-officio member of all standing committees of the Board.

In commenting on Matthew's appointment, J.C. Johnston III, immediate Past-President, said: "Steve's commitment to the community as a local business owner will serve the Foundation well. I am confident that under his leadership WCCF will continue to play a leading role in the philanthropic efforts of individuals, corporations, and other nonprofit agencies in Wayne County."

Matthew is President of Wooster Hydrostatics Inc., an international supplier of remanufactured hydraulic components based in Wooster. Active in the community, Matthew is a past Chairman of the Wooster Area Chamber of Commerce, past Chairman of the Wayne Economic Development Council, a Trustee of the Noble Foundation, and has served on the board of The Village Network.

Matthew replaces Johnston, who has stepped down after nine years as President and will remain an active member of the Foundation's board, serving as Chair of the Investment Committee, and representing the Wooster area as he has since 1997. His history with the Foundation goes back more than 35 years, when he performed most of the legal work involved in establishing the Foundation.

Matthew noted his appreciation for Johnston's leadership through a period of significant growth for the Foundation. "Because of the work J.C. and others have done, we have a great story to tell, and I'm excited to be part of it."

Over \$411,000 in scholarships awarded

Robert Eckardt to speak at Foundation's Annual Dinner



WCCF will hold its annual dinner on Wednesday, October 8th. Designed to inform our donors and the community of the Foundation's recent events and accomplishments, the annual dinner is a time to celebrate philanthropy in Wayne County and to thank our many donors for their support. This year we will also be honoring *Friend of Philanthropy* award recipients, the Smucker Family (see article on page 1).

We are very pleased to have as our speaker this year Mr. Robert Eckardt, Executive Vice President of the Cleveland Foundation. Established in 1914, the Cleveland Foundation was the very first community foundation...and went on to inspire a global movement. Within five years, community foundations had sprung up in Chicago, Boston, Milwaukee, Minneapolis, and Buffalo, N.Y. Now, more than 700 community foundations in the United States collectively manage more than \$48 billion in assets and distribute some \$4.5 billion a year to community needs. Moreover, the idea has emigrated: Some 1,700 community foundations now exist worldwide.

Eckardt joined the Cleveland Foundation in 1982 and has served as senior program officer in the areas of health, aging, and environment. He also created the foundation's first formal evaluation effort. In his current role as Executive Vice President, Eckardt provides overall direction to the Cleveland Foundation's grantmaking, working with the board, staff, and community leaders to pinpoint the region's critical needs and leverage resources to help meet them.

Be sure to mark your calendars now and join us on October 8th. This year, the event will be held at the Arden Shisler Conference Center on the OARDC campus with catering by The Wooster Inn. Social hour will begin at 5:30pm, with the dinner and program following shortly after.

The Women's Fund Accepting grant applications

The Women's Fund, an affiliate fund of Wayne County Community Foundation, is accepting grant applications from nonprofit agencies whose work enables women in Wayne County, Ohio, to change their lives for the better. The Fund focuses on three areas: education, economic empowerment, and health and wellness.

As a permanent endowment, gifts are invested and continue to grow over time. Each year, the earnings on those gifts will be used to make grants to programs that encourage the full participation of women and girls in our community, as well as those that create opportunities for their educational and personal growth.

In this first year, the Fund will award one \$15,000 grant to the proposal which demonstrates the most effective use of the grant dollars and has the greatest chance for success. The grant must benefit women and girls living in Wayne County, Ohio.
