A Year of Milestones 2023 Marks 45th Anniversary of WCCF

"It will never work in Wayne County." That was the general consensus of a six-month feasibility study in 1978. At that time, community foundations were in cities with much larger population centers; but the small group of citizens charged with exploring the idea of community philanthropy knew the study was underestimating the generosity and community spirit of Wayne County residents. Thus, they pushed forward – and on December 6, 1978, what is known today as Wayne County Community Foundation was officially incorporated. Starting with an initial gift of \$1,000, the Foundation now manages over \$112 Million in assets and has awarded over \$106 Million in grants and scholarships back into the community.

In addition to marking the 45th anniversary of the Foundation, **2023 also** brings the **10-year anniversaries of two of our affiliate programs**, Wayne County Community Youth Foundation and The Women's Fund.

The **Youth Foundation** provides a unique opportunity for high school juniors throughout Wayne County to experience the impact and importance of community-based philanthropy. Participants engage with area nonprofits through grantmaking activities and community service projects, while also participating in team-building and leadership activities. Since being established in 2013, over 300 area students have completed the program – and over \$50,000 grants have been provided for projects benefiting Wayne County youth.

Also established in 2013, **The Women's Fund** works to improve the lives of women of all ages by supporting programs that empower change and self-sufficiency. This permanent endowment fund is operated by women, for women. Today, the Fund has grown to nearly \$850,000 and has provided \$166,650 in grants to nonprofits that focus on addressing education, economic empowerment, or health and wellness issues for women.

Since our founding 45 years ago, the Foundation has partnered with individuals, families, businesses, and nonprofits in Wayne County to address the community's most pressing needs. Together, we can direct our efforts where we can have the most positive impact – today, tomorrow, and forever.

The Women's Fund is able to support a wide array of programs affecting the lives of women in Wayne County. One such project is the Electronic Fetal Monitoring (EFM) Certification Initiative at Wooster Community Hospital. EFM allows the baby to "communicate" while in the womb and is an effective tool in determining the health of the baby and mother during the labor and delivery process.

How to leave a planned gift to the Community Foundation:

- Leave a Bequest Include the Foundation in your will as the beneficiary of assets you wish to donate. Committing a portion of your bequest this way removes the assets from your taxable estate. You can use cash, stocks, bonds, or tangible property to make these gifts.
- Retirement Funds and IRAs –
 Naming the Foundation as the beneficiary of your IRA, 401(k), or 403(b)may help to avoid income and estate taxes upon your death. You can benefit your favorite causes and continue to withdraw from your plan during your lifetime.
- <u>Life Insurance</u> Pay an annual premium for a new or existing life insurance policy and designate the Foundation as the primary or contingent beneficiary. You can also gift a life insurance policy you own and no longer need.
